

ACTION IS TAKEN IN INTERESTS OF PEACE

future will adopt a line of action toward Germany.
The announcement came some two hours after Hitler had received the Czechoslovak envoy in the Reichstag, scene of the historic Munich conference which two weeks ago sealed the fate of Czechoslovakia in Hitler's hands.
The official account of the meeting said the Führer had expressed his regret that the question of Czechoslovakia's Hungarian minority had not yet been solved and had told Chvalkovsky that he hoped an amicable solution of this problem would be found.
"Some circles said Hitler in his minute conversation with the Czech envoy, took occasion to discuss all questions involving both the Komran conference, in which Hungary sought from a Slovak delegation representing Prague the return of her demands for Hungarian-populated areas of Slovakia, and yesterday's without precedent and Hungary announced she would take her case to the four powers of the Munich accord."
A leader of the Slovak delegation said Hungary had demanded 339 square miles with a population of 1,120,000. Czechoslovakia had offered to cede 2,132 square miles with 378,000 population.
Chvalkovsky, a former minister in Berlin, Rome and Tokyo who was named foreign minister of the re-constituted government last week, arrived in Germany yesterday to learn Hitler's will concerning the future of his diminished country.
Nazi circles believed Hitler demanded among other things abandonment of Czechoslovakia's alliances with Soviet Russia and France.

Munich, Oct. 14. (AP)—Disembodied Czechoslovakia and expanded Hungary today laid their conflicting causes before Adolf Hitler in his glistening Fuehrerhaus here, scene of the fateful Munich conference of Sept. 29.
It was a day of personal triumph for the German Führer, to whom most of Central Europe appeared to be looking for settlement of its problems.
First came Fantisek Chvalkovsky, new foreign minister of Czechoslovakia, to give what a German communique called "assurance that Czechoslovakia would assume a loyal attitude toward Germany."
A little later came by airplane a Hungarian mission headed by Koloman Daranyi, to seek the Führer's mediation in Hungary's claims for a large slice of southern Slovakia.

Sofia, Bulgaria, Oct. 14. (AP)—The government invoked nationwide police precautions against political terrorism today after the discovery of a revolutionary plot against the government.
Precautionary steps apparently were directed chiefly against the outlawed Imro, an organization of extremist Macedonians wanting an autonomous state including the 2,000,000 Macedonians now living in Bulgaria, Yugoslavia and Greece.
The government arrested several thousand persons, most of whom were released after questioning, and seized large stores of arms.
Officials believed the assassination Monday of Major General Jordan Peyerl, chief of the Bulgarian army general staff, was to have been the signal for revolution.

Vatican City, Oct. 14. (AP)—L'Osservatore Romano, the Vatican newspaper, today accused German authorities of defending the Nazi mob which attacked the Vienna palace of Theodore Cardinal Innitzer last Saturday night with "the impudent excuse of Catholic provocation."
The Vatican organ in indignant terms declared that the attack on the cardinal's palace was "the poisoned fruit of daily unpunished, encouraged campaigns of anti-Catholic accusations and vituperation."
L'Osservatore Romano's comment was appended to a long version of the attack as reported from Vatican sources.

Canton To Be Evacuated If Japanese Advance

planes and artillery were being used with crushing force.
With the destruction of a long wooden bridge about 15 miles north of Hongkong, Canton was cut off completely except for the highway to Waichow and the water route to Macao, Portuguese colony 70 miles south of Canton.
Chinese military supplies from Hongkong were blocked, and it was learned a caravan of 160 trucks, by which an effort was made to send materials to Canton, was forced to return here after finding the bridge destroyed.
Events were moving rapidly in Kwangtung provinces, of which Canton is the capital. Provincial and municipal archives, it was learned, were being sent to Yung-yuen, in northern Kwangtung. Government officials were expected to leave shortly by special train.
Heavy Chinese reinforcements were being rushed to Cheungmutau, on the Canton-Kowloon railway, and to Waichow, where a bitter battle was expected.
Kwangtung authorities were reported to have asked the consular body of the Shanghai foreign settlement of Canton to convey to the Japanese a request that Lingnan University and the French Catholic Cathedral in Canton be declared safety zones for non-combatants.
More than 300 foreigners, including 80 Americans, the United States gunboat Mindanao, with one French and five British war vessels, were bottled up in waters near Canton.
Dispatches from Canton this evening said Waichow was in flames after day-long bombings by Japanese planes. The number killed and wounded was estimated at more than 1,000.
From Swatow came reports that ten Japanese transports with an escort of a cruiser and three destroyers had left that port. It was assumed the destination was either Blas Bay or the Pearl River delta south of Canton. Another dispatch said the Japanese had made another landing of troops at a point ten miles west of Hongkong.
